CONDITIONS OF THE LICENCE

The Licence is subject to following conditions

1. The Licence shall be non-transferable.
2. The number of workmen employed as contract labour in the establishment shall not, on any day exceed as given in the licence above.
3. Except as provided in the rules the fees paid for the grant, or as the case may be, for renewal of the licence shall be non-refundable.
4. The rates of wages payable to the workmen by the Contractor shall not be less than the rate prescribed for in the schedule of employment under Minimum Wages Act, 1948 where applicable and where the rates have been fixed by agreement, settlement or award not less than the rates fixed.
5. In case where the workmen employed by the contractor perform the same kind of work the workmen directly employed by the principal employer by the establishment, the hours of worker and other conditions of service of the workmen of the contractor shall be same as applicable to the workmen directly employed by the principle of the establishment.
6. In other cases the hours of work and conditions of service of the workmen of the contractor shall be such as may be specified in this behalf by the Labour Commissioner.
7. In every establishment where 20 or more women are ordinarily employed as contract labour, there shall be provided 2 rooms of reasonable dimensions for the use of their children under the age of six years. One of such room would be used as the playroom for the children and other as bed room for children. For this purpose the contractor shall supply adequate number of toys and games in the playroom and sufficient number of cots and bedding in the sleeping room. The standard of construction and maintenance of the creches may be such as may be specified in this behalf by the Labour Commissioner.
8. The licensee shall intimate any change in the number of workmen or the conditions of work to the Licensing Officer.
9. The contractor will be available and accessible to the workers at the work site.
